


4 Days' Training Program on Laboratory Quality Management System & Internal Audit as per ISO/IEC 17025:2017



During 16 to 19 December 2025

About the Program

This 4 day's training program on LQMS & Internal Auditing as per ISO/IEC 17025:2017 is designed to equip individuals to understand and implement ISO/IEC 17025:2017 requirements for Testing / Calibration Laboratories, Laboratory Management System documentation as required by the standard, measurement uncertainty concepts & internal audit. Upon successful completion of this course, the participants will gain knowledge and understanding of the ISO/IEC 17025:2017 standard for Laboratory Accreditation & internal auditing, and get training certificate.

Course Objecives

- Understanding ISO/IEC 17025:2017 requirements:
 - This includes clauses related to management system requirements, resource requirements, process requirements, and improvement.
- Auditing principles and techniques:
 - O Participants learn about the different types of audits, audit planning, on-site audit activities, and reporting findings.

Who should attend

Laboratory managers and supervisors, Quality managers and quality professionals, Technical staff involved in laboratory operations, Individuals responsible for implementing and maintaining the laboratory management system, and Consultants working with laboratories. Laboratory personnel in the areas of instrument calibration, food and chemical testing can gain & improve knowledge from this program.

Resource Person

The resource person for this programme is Mr. R. Ramar, a trained auditor who has undergone extensive training and working experience in the subject and has conducted a number of programmes in this area. Lecture sessions, group exercises, mock audit and final evaluation test are part of the programme.

Duration and Timings

Four days (16 to 19 December 2025) 9.30 hrs to 17.30 hrs on all days

Eligibility

Diploma/Bachelors/Master's degree in Engineering/Science with relevant work experience in the field of measurements either in maintenance, inspection, testing / calibration laboratory or QA.

Certification

It is mandatory to attend all sessions of the programme and the "Training Certificate" will be given only for the successful participants.

Course Fee

Rs. 14,160/- (inclusive of GST @18%) per participant. Fee includes course materials, working lunch and tea breaks. The Course Fee to be paid in advance by NEFT (A/c. No. 57014606821, SBI – CUSAT Branch, IFSC: SBIN0070235) or by at par cheque in favour of The Director, STIC payable at Ernakulam.
